- ❑ **CORI Form** ~ must be completed each academic year and returned in person with a copy of your drivers license to Mrs. Holly Breen, in the SPS Main Office.
- ❑ **Code of Ministerial Conduct Form** ~ acknowledgement of understanding the behavioral rules and guidelines for those providing service to children *requires completion once*. These guidelines are available in the Main Office for review. Witness of signature necessary. Completed forms are to be submitted to the SPS Main Office.
- ❑ **VIRTUS ("Protecting God's Children) Training** ~ *one-time completion (certification issued), only*. Proof of certification required annually.
